Food Safety Certifications Invalidated for Hundreds of Restaurants

Certification holders will have 60 days to be re-tested, re-certified

SAN FRANCISCO (Aug. 25, 2009)—Today, the San Francisco Department of Public Health (DPH) will be notifying 345 San Francisco restaurants that their certification for food safety managers will no longer be recognized as valid as a result of inappropriate testing and certification procedures. Officials from DPH also informed state and county public health authorities throughout California of at least 183 additional restaurants outside of San Francisco whose certifications are similarly affected. Another 78 certifications whose holders list no address have also been identified.

Today's unprecedented enforcement action follows an investigation initiated by DPH and conducted by City Attorney Dennis Herrera's office that uncovered significant irregularities in the administration of the exams by three DPH food inspectors working independently and without the authority of the Department.

Herrera's investigation found that numerous Food Safety Certifications had been issued to individuals who never actually took the examination. Other examinees were given the correct answers during the course of the exam, and in still other instances test materials and correct answers were shared with examinees before the test was administered.

Two of the three DPH food inspectors are no longer employed with the City, and an investigation continues into the conduct of the third employee.

"Because the reliability of Food Safety Certifications is essential to public health, the Department has determined that the above certification is no longer valid," DPH's Occupational and Environmental Health Director, Dr. Rajiv Bhatia, wrote in letters to affected restaurants and certificate holders today. "We understand that obtaining a new certification is time-consuming and that the need to do so in the next 60 days may be frustrating. However, we hope that your business shares the Department's commitment to meeting the highest standards regarding food safety, and trust that you understand the importance of ensuring that all retail food establishments have reliable Food Safety Certifications."

The notices sent this morning allege no wrongdoing or immediate food safety problems on the part of restaurants or individual certificate holders. Rather, City public health authorities have determined that affected certificate holders must be recertified. State law requires food facilities to have at least one

employee or owner who has successfully passed an approved and accredited Food Safety Certification examination. The affected restaurants will have 60 days to obtain new certifications, or to inform DPH that another validly certified staffer can fulfill the required role.

Bhatia additionally informed the California Department of Public Health and his counterparts in California's 57 other counties of the testing irregularities uncovered, together with San Francisco's response, noting that, "given the statewide and national portability of Food Safety Certifications, many California counties are likely to be affected by this issue."

In addition, Herrera's office today contacted the two certification organizations who licensed the three former DPH inspectors to conduct the Food Safety Certification examinations—the National Registry of Food Safety Professionals and National Restaurant Association Solutions—informing them of their responsibility to establish effective safeguards against such misconduct, and to contact his office's Chief Trial Deputy for further discussions.

Dear Restaurant Owner/Manager:

The San Francisco Department of Public Health has discovered irregularities in the administration of some of the examinations required to obtain a Food Safety Certification. The Department has determined that the above Food Safety Certification may be affected. Because the reliability of Food Safety Certifications is essential to public health, the Department has determined that the above certification is no longer valid.¹

As a result of the Department's determination, you must take certain steps to remain in compliance with California law regarding food safety. California law requires that your business have an owner or employee on staff who has successfully passed an approved and accredited Food Safety Certification examination. Health & Safety Code section 113947.1. That owner or employee must perform the responsibilities identified under Health & Safety Code section 113949.2. Under California law, a business that no longer has a validly certified owner or employee must come into compliance within 60 days. Health & Safety Code section 113947.1(e).

Therefore, you may come into compliance in two ways:

1. If another owner or employee on your staff has a valid Food Safety Certification issued in the past five years, please send a copy of the certification to Department of Public Health, Attn: Food Safety Certification Validation, 1390 Market Street, Suite 210, San Francisco CA 94102. The Department will review the certification and inform you whether it is valid. If the certification is valid, you may assign that certified owner or employee to perform the responsibilities identified under Health & Safety Code section 113949.2. If you do so, no further action will be necessary.

2. If no owner or employee has a valid Food Safety Certification, then the owner or an employee must obtain a new certification within 60 days of the date of this letter. A new certification may be obtained by taking and passing a new examination. The required examination may be given by any person licensed by an organization that meets the requirements of Health & Safety Code section 113947.3. The Department offers an intensive all-day training regarding food safety and is licensed to give the required examination. Further information regarding the Department's course and examination schedule is enclosed. (The training is

offered separately from the examination and you may take only the examination if you wish.)

You are not required to use the Department to obtain a new certification; you may take the examination from any licensed examiner.

The owner or employee who successfully passes the examination and obtains the new certification must then be assigned to perform the responsibilities identified under Health & Safety Code section 113949.2.

We understand that obtaining a new certification is time-consuming and that the need to do so in the next 60 days may be frustrating. However, we hope that your business shares the Department's commitment to meeting the highest standards regarding food safety, and trust that you understand the importance of ensuring that all retail food establishments have reliable Food Safety Certifications. Dear Certificate Holder:

The Department of Public Health has discovered irregularities in the administration of some of the examinations required to obtain a Food Safety Certification. The Department has determined that the above Food Safety Certification may be affected. Because the reliability of Food Safety Certifications is essential to public health, the Department has determined that the above certification is no longer valid.¹ The Department has also notified other California county departments of public health of its determination.

Steps That You Must Take If You Are An Employee Of A Food Facility

If you are currently an employee of a food facility (including a restaurant) and you are assigned to instruct other employees regarding food safety or to perform the other food safety responsibilities under Health & Safety Code section 113949.2, then you must immediately show the food facility owner or manager this letter.

If you wish to obtain a Food Safety Certification that San Francisco will treat as valid, then you must take and pass a new examination. You may take the required examination from any person licensed by an organization that meets the requirements of Health & Safety Code section 113947.3. The Department offers an intensive all-day training regarding food safety and is licensed to give the required examination. Further information regarding the Department's course and examination schedule is enclosed. (The training is offered separately from the examination and you may take only the examination if you wish.) You are not required to use the Department to obtain a new certification; you may take the examination from any licensed examiner.

ATTENTION

If You Are The Owner Of A Food Facility And Your Employee Shows You This Letter, You Must Carefully Read The Following Instructions

California law requires that food facilities have an owner or employee on staff who has successfully passed an approved and accredited Food Safety Certification examination. Health & Safety Code section 113947.1. That owner or employee must perform the responsibilities identified under Health & Safety Code section 113949.2. Under California law, a business that

no longer has a validly certified owner or employee must come into compliance within 60 days. Health & Safety Code section 113947.1(e).

San Francisco no longer recognizes the Food Safety Certification issued to the above employee. If your restaurant is within San Francisco, your food facility must come into compliance under Health and Safety Code section 113947.1(e), as described below. If your restaurant is in another county, you should immediately contact your county Department of Public Health/Director of Environmental Health to determine whether your food facility must take any steps to come into compliance.

San Francisco food facilities may come into compliance in two ways:

1. If another owner or employee on the food facility staff has a valid Food Safety Certification issued in the past five years, the food facility owner should send a copy of the certification to Department of Public Health, Attn: Food Safety Certification Validation, 1390 Market Street, Suite 210, San Francisco CA 94102. The Department will review the certification and inform the owner whether San Francisco will treat it as valid. If the certification is valid, the owner may assign that certified owner or employee to perform the responsibilities identified under Health & Safety Code section 113949.2. If the owner does so, no further action will be necessary.

2. If no owner or employee has a valid Food Safety Certification, then the owner or an employee must obtain a new certification within 60 days of the date of this letter. A new certification may be obtained by taking the required examination from any person licensed by an organization that meets the requirements of Health & Safety Code section 113947.3. The Department offers an intensive all-day training regarding food safety and is licensed to give the required examination. Further information regarding the Department's course and examination schedule is enclosed. No one is required to use the Department to obtain a new certification; a person may take the examination from any licensed examiner.

The owner or employee who successfully passes the examination and obtains the new certification must then be assigned to perform the responsibilities identified under Health & Safety Code section 113949.2.

We understand that obtaining a new certification is time-consuming and that the need to do so in the next 60 days may be frustrating. However, we know that you share the Department's commitment to meeting the highest standards regarding food safety, and trust that you understand the importance of ensuring that all retail food establishments have reliable Food Safety Certifications. Re: Invalid Food Safety Certifications

Dear County Director of Environmental Health:

I write to inform you that the San Francisco Department of Public Health has discovered irregularities in the administration of some of the examinations required to obtain a Food Safety Certification related to the safety of food facilities in San Francisco and in other jurisdictions. (Health & Safety Code § 113947.1.) As a result, San Francisco DPH is no longer treating certain Food Safety Certifications as valid. (A list of those certifications is attached for your reference.) We share this information with you so that your office can take the steps that you deem appropriate for the protection of public health within your jurisdiction.

San Francisco DPH made its decision after an investigation conducted at our request by the San Francisco City Attorney's Office. That investigation (which remains ongoing) revealed that three San Francisco DPH inspectors were privately administering Food Safety Certification examinations in San Francisco and that they engaged in a range of improper conduct in administering these examinations. The City Attorney's investigation found, among other things, that in certain instances individuals received a Food Safety Certification without taking any examination at all; in other instances, examinees were given the correct answers during the examination; and in other instances, the test materials and correct answers were shared with examinees before the actual examination. In addition, the inspectors' administration of Food Safety Certification examinations for private profit in San Francisco constituted an improper conflict of interest with their public health enforcement responsibilities.

The findings of the City Attorney's investigation to date are sufficient to undermine our Department's confidence in the results of any Food Safety Certification examination administered by these individuals. Because the reliability of Food Safety Certifications is essential to public health, San Francisco has determined that Food Safety Certifications issued by certifying organizations as a result of examinations administered by these individuals cannot be treated as valid.


On August 25, 2009, San Francisco is sending a letter to each certification holder for whom we have an address. (A sample letter to certification holders is attached for your reference.) We are informing these certification holders that San Francisco will no longer recognize those certifications as valid. Among other things, those letters direct certification holders who are employed by a food facility to show the letter to the food facility owner so that the owner can contact the appropriate county Department of Public Health to determine what steps may be required to take to remain in compliance with the Health & Safety Code. Therefore, Departments of Bay Area and other nearby counties should anticipate receiving such calls shortly.

The number of persons and restaurants affected by our determination is substantial. We are sending this letter to 542 holders of a Food Safety Certification issued by the National Registry of Food Safety Professionals, and to 194 holders of a Food Safety Certification issued by the National Restaurant Association (ServSafe). We are sending separate letters to the owners of the 345 San Francisco restaurants with addresses that match the addresses given by holders of these certifications, so that the restaurant owners can take steps to ensure that they each have a properly certified food safety manager as required by Health & Safety Code section 113947.1. (A sample of the letter to restaurant owners is attached for your reference.) While most affected certification holders have San Francisco addresses, 183 certification holders have addresses outside San Francisco, and there are 78 more certification holders for whom we have only a name and certificate number, but no address. Moreover, given the statewide and national portability of Food Safety Certifications, many California counties are likely to be affected by this issue.

In addition to contacting each of you, we have contacted the California Department of Public Health. We are also contacting the two certification organizations who authorized these individuals to administer Food Safety Certification examinations: the National Registry of Food Safety Professionals and National Restaurant Association Solutions (ServSafe). We hope that these organizations will establish more effective safeguards against the type of misconduct described here.

Dear Mr. Fenlon:

We represent the City and County of San Francisco, including its Department of Public Health. The Department is charged with enforcing California food safety laws in San Francisco food facilities. Among other things, food facilities must have at least one employee or owner who has successfully passed an approved and accredited Food Safety Certification examination. Cal. Health & Safety Code § 113947.1. Your organization, National Restaurant Association Solutions, is accredited to give such examinations pursuant to Cal. Health & Safety Code § 113947.3 under the name "ServSafe Food Safety Manager Certification Exam." Your role as such an examiner is a significant public health responsibility and that is why we are contacting you.

At the request of the San Francisco Department of Public Health, our office is conducting an investigation of individuals that National Restaurant Association Solutions licensed as food safety instructors and examination administrators.¹ Our investigation has revealed that two San Francisco DPH inspectors licensed by your organization were privately administering National Restaurant Association Solutions Food Safety Certification examinations as well as examinations through another certification organization. We have learned that these inspectors engaged in a range of improper conduct in administering examinations through the other certification organization. Our investigation has found, among other things, that in certain instances individuals received certifications without taking any examination at all; in other instances, examinees were given the correct answers during the examination; and in other instances, the test materials and correct answers were distributed to examinees before the actual examination. We are concerned that they may have engaged in the same conduct in administering the National Restaurant Association Solution examination. In particular, we note that examination given by these two inspectors appear to have unusually high pass rates. One administered 182 exams, and 178 examinees passed (97.8% pass rate). The other administered 101 exams, and 94 examinees passed (93% pass rate). Finally, the inspectors' administration of your examinations for private profit also constituted an improper conflict of interest with their public food safety enforcement responsibilities.

The findings of our investigation to date are sufficient to undermine confidence in the results of any certification examination administered by these individuals. Because the reliability of Food Safety Certifications is essential to public health, the San Francisco Department of Public Health has determined that the 272 Food Safety Certifications that your organization has conferred through these individuals can no longer be treated as valid in San Francisco. At least 76 San Francisco restaurants are affected by this determination. San Francisco will incur substantial costs to re-train and re-certify food facility owners and employees, and to re-inspect these restaurants.

Moreover, given the statewide and national portability of your organization's certifications, other jurisdictions are affected by this issue. The Department has informed its counterparts at the California Department of Public Health and in every other California county of these findings, so that they can take the appropriate steps to ensure the public health within their respective jurisdictions.

We are concerned that during the time that these individuals have been licensed by National Restaurant Association Solutions, it may not have adequately monitored their exam administration practices. We expect that National Restaurant Association Solutions is as concerned as we are that the reliability of the ServSafe Food Safety Manager Certification Exam may have been compromised, and will wish to conduct an investigation and take other steps to protect the integrity of its certifications. Moreover, we understand that accreditation of National Restaurant Association Solutions as a qualified examiner is based in significant part on the reliability of its examination results, which in turn depends on properly monitoring the performance of examination administrators.



Dear Mr. Belmont:

We represent the City and County of San Francisco, including its Department of Public Health. The Department is charged with enforcing California food safety laws in San Francisco food facilities. Among other things, food facilities must have at least one employee or owner who has successfully passed an approved and accredited Food Safety Certification examination. Cal. Health & Safety Code § 113947.1. Your organization, the National Registry of Food Safety Professionals (National Registry), is accredited to give such examinations pursuant to Cal. Health & Safety Code § 113947.3 under the name "Food Safety Manager Certification Examination." Your role as such an examiner is a significant public health responsibility and that is why we are contacting you.

At the request of the San Francisco Department of Public Health, our office is conducting an investigation of individuals that National Registry licensed as food safety instructors and examination administrators.¹ Our investigation has revealed that three San Francisco DPH inspectors licensed by your organization were privately administering National Registry examinations in San Francisco. These inspectors engaged in a range of improper conduct in administering Food Safety Certification examinations. Our investigation has found, among other things, that in certain instances individuals received a National Registry Food Safety Certification without taking any examination at all; in other instances, examinees were given the correct answers during the examination; and in other instances, the test materials and correct answers were shared with examinees before the actual examination. Moreover, the three inspectors appear to have unusually high pass rates for the National Registry examinations that they privately administered. One administered 13 exams and all 13 examinees passed (100% pass rate). Another administered 126 exams and all 126 examinees passed (100% pass rate). The third administered 405 exams since December 2005, and only 2 examinees failed (99.5% pass rate). Finally, the inspectors' administration of your examinations for private profit constituted an improper conflict of interest with their public food safety enforcement responsibilities.

The findings of our investigation to date are sufficient to undermine confidence in the results of any National Registry Food Safety Manager Certification Examination administered by these individuals. Because the reliability of Food Safety Certifications is essential to public health, the San Francisco Department of Public Health has determined that the 542 Food Safety Certifications that your organization has conferred through these individuals since December 2005 can no longer be treated as valid in San Francisco. At least 269 San Francisco restaurants are affected by this determination. San Francisco will incur substantial costs to re-train and re-certify food facility owners and employees, and to re-inspect these restaurants.

Moreover, given the statewide and national portability of your organization's certifications, other jurisdictions are affected by this issue. The Department has informed its counterparts at the California Department of Public Health and in every other California county of these findings, so that they can take the appropriate steps to ensure the public health within their respective jurisdictions.

We are dismayed that during the time these persons have been licensed by National Registry to administer its examinations, National Registry appears not to have adequately monitored their exam administration practices. We expect that National Registry is as concerned as we are that the reliability of the National Registry Food Safety Manager Certification Examination has been compromised, and will wish to conduct an investigation and take other steps to protect the integrity of its certifications. Moreover, we understand that accreditation of National Registry as a qualified examiner is based in significant part on the reliability of its examination results, which in turn depends on properly monitoring the performance of examination administrators.


