JUDGMENT

1 Plaintiff the People of the State of California ("the People") and Defendants Dollar Financial
2 Group, Inc., Monetary Management of California, Inc., and Money Mart Express, Inc. ("Dollar
3 Defendants"), have executed a Settlement Agreement and Release, and presented it along with a
4 Stipulated Injunction and Order for the Entry of Judgment to Department 304 of the San Francisco
5 Superior Court, the Honorable Richard A. Kramer presiding. The People and the Dollar Defendants
6 consent to entry of this Judgment and waive their respective rights to a noticed motion, hearing, or
7 trial. The People and the Dollar Defendants agree that this Judgment shall be entered and become
8 final for all purposes upon entry thereof, and they waive any right to appeal therefrom.

9 Accordingly, **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** as follows:


10 A. The People shall take nothing further from the Dollar Defendants in connection with
11 their First Amended Complaint except as provided in the Stipulated Injunction signed on October
12 19, 2011, and as provided in the Settlement Agreement and Release executed by the People and the
13 Dollar Defendants.

14 B. The People shall take nothing from defendant First Bank of Delaware ("FBD") in
15 connection with the First Amended Complaint insofar as it relates to any loans made pursuant to or
16 in connection with any agreements between FBD and Dollar Financial Group.

17 C. This Court shall retain jurisdiction to enforce this Judgment pursuant to California Code
18 of Civil Procedure section 664.6.
